


The mission of The City University of New York, embodied in state education law, Article 125, Section 6201, as the finding and intent of the New York State Legislature, states in part:

"The Legislature intends that The City University of New York should be maintained as an independent system of higher education governed by its own Board of Trustees responsible for the governance, maintenance and development of both senior and community college units of The City University.

"The University must remain responsive to the needs of its urban setting and maintain its close articulation between senior and community college units. Where possible, governance and operation of senior and community colleges should be jointly conducted or conducted by similar procedures to maintain the University as an integrated system and to facilitate articulation between units.

"The Legislature's intent is that The City University be supported as an independent and integrated system of higher education on the assumption that the University will continue to maintain and expand its commitment to academic excellence and to the provision of equal access and opportunity for students, faculty and staff from all ethnic and racial groups and from both sexes. The City University is of vital importance as a vehicle for the upward mobility of the disadvantaged in the City of New York. The pioneering efforts of the SEEK and College Discovery programs must not be diminished as a result of greater state financial responsibility. [Read Less](#) »

## HISTORY

BOASTING WORLD-CLASS ACADEMICS, award-winning faculty and both new and enhanced campuses, today's City University of New York is attracting students who win National Science Foundation fellowships and Rhodes Scholarships, keeping a nearly 170-year-old commitment to educational excellence and opportunity.

Our mission dates to 1847 when founder Townsend Harris, an early champion of public education and a pioneering diplomat who was the first U.S. ambassador to Japan, called upon New York City to create a public academy of higher learning to "educate the whole people."

An inaugural class of 143 academically qualified young men was soon assembled. The fledgling school quickly grew in reputation and enrollment and, as a new century approached, plans were approved for an expansive neo-Gothic campus uptown that became the College of the City of New York.



The Normal School, the first to offer free education to women, became Hunter College in 1914.

Twenty years after the first students entered the academy, a second school for the education of teachers, the Female Normal and High School – later renamed Hunter College in honor of its founder, Thomas Hunter – offered the same higher education opportunities to women.

Fueled by an immigration boom in the early 20th century, City College and Hunter expanded to include evening sessions in Brooklyn and Queens. In 1926, the state Legislature established a Board of Higher Education to oversee the growing municipal college system and expand public access in the city's outer boroughs. Over the next decade, Brooklyn College and Queens College were founded and Hunter established a Bronx campus, which decades later would become Lehman College.

Despite the city's limited resources, demand for public higher education continued to grow during the Great Depression. The colleges created night divisions that charged affordable tuition

**BENNO SCHMIDT, B.A. J.D.**, was appointed by Governor George Pataki in April 2003 as Chairperson of the Board of Trustees of The City University of New York. He was reappointed to the Board for a seven-year term in June 2006.

Previously he served as Vice Chairperson upon his appointment in August 1999. 


ORGANIZATIONAL CHART – OFFICE OF UNDERGRADUATE STUDIES





## Mission Statement

The College's mission statement encapsulates essential purposes, values, and characteristics. It is therefore indispensable to all future planning. While the strategic plan will set out goals and strategies to realize a clear vision for the institution, it will and can do so only in keeping with the ideals expressed in the Brooklyn College mission statement:

Brooklyn College is a comprehensive, state-funded institution of higher learning in the Borough of Brooklyn, a culturally and ethnically diverse community of two-and-one-half million people. As one of the eleven senior colleges of The City University of New York, it shares the mission of the university, whose primary goals are access and excellence.

Within the context of this broader mission, the particular mission of Brooklyn College is to provide a superior education in the liberal arts and sciences. The College offers a wide variety of programs, both in the liberal arts and in professional and career-oriented areas, leading to the baccalaureate and master's degrees and to undergraduate and advanced certificates.

Distinctive in this liberal arts education is the Core Curriculum, which is required of all baccalaureate students. The Core has long been a national model for general education programs and for faculty and curriculum development. The Core Studies courses are designed to expose students to the principal branches of learning—the arts, humanities, social sciences, and sciences—and to provide a rigorous foundation for study in a major field.

Through its distinguished faculty, the College promotes excellence in teaching, advances the frontiers of knowledge through research and scholarship, and stimulates creative achievement and intellectual growth.

The overarching goal of the educational experience at Brooklyn College is to provide students with the knowledge and skills to live in a globally interdependent world and the support services to help them succeed. The College also seeks to develop a sense of personal and social responsibility by encouraging involvement in community and public service. It fosters a campus environment hospitable to multicultural interests and activities. Moreover, as an urban institution, it is able to draw upon the myriad resources of the city to enhance its educational mission.

The College seeks to extend its educational mission to graduate students through advanced programs offered by the Division of Graduate Studies. The academic goals of the division build on the college's tradition of academic excellence in the liberal arts and sciences and in teacher education programs. The division offers studies in specialized areas to serve the growing number of adults who seek to continue their intellectual pursuits and broaden their professional goals. In addition, in order to meet the changing needs of society, the College has developed new interdisciplinary degree and certificate programs as well as new concentrations of courses in existing programs. The College participates in a range of doctoral programs offered by the Graduate Center of The City University of New York, including campus-based programs in the sciences.




